the Planning Board and Board of Elections for over 30 years. She was loved by her family and friends and we all respected and appreciated her dedication to her work for the Town. In August 2011, Marian was named Montezuma Citizen of the Year for her outstanding service to the Town at a picnic given in her honor at the town pavilion.

Members of the Town Planning Board knew when questions around former land issues came up we could always turn to Marian to recall all the details involved. She worked hand-and-hand with the Planning Board's Comprehensive Planning Committee to create the Town's first Plan and updated zoning ordinance, and she was always willing to share her ideas for what she considered in the best interest of the Town.

Marian was a part of the Stop 69 community where neighbors look out for each other. She knew she could call on Steve Wunder and Tom and Diane Fitizsimmons to help her often especially after her husband Don passed away. Her friends, the Belknaps' made sure she got to doctor appointments. She especially enjoyed special long day-trip rides with them that included stops for ice cream. Several other friends and church members made sure she was always remembered and cared for especially Veronica Coughlin. She was a dedicated member of the Montezuma Historical Society and especially loved the Butterly Garden where she had walkway bricks dedicated to her predeceased family members. She always looked forward to and especially enjoyed visits from her brother, Walt and family.

I loved her wit, humor and lightheartedness. One thing I know for sure her secret to a long, enriching life was *chocolate*, humor and a steadfastness to doing what she believed was right.
