*The Highway Department has been working with limited staff and appreciates your patience to give them time to schedule this year's Clean up Days. Due to new regulations by the trash hauling company and landfill requirements, new rules **MUST BE** followed. Your cooperation will make the service go much smoother and is much appreciated.*

NEW RULES: The Town will **not accept** any building materials and house walls. The Highway Department has the right to refuse any loads that do not follow these new rules. Highway staff also have the right to limit the number of loads brought in due to abuse in the past.

NOT ACCEPTED:

- mattresses or box springs
- tires, auto parts
- paint cans, or anything that has the capability of holding water such as plastic barrels
- hot tubs (acceptable if cut into pieces)
- NO Electronics, TV's, Computers
- NO Refrigerators/Freezers/Air Conditioners/Propane Tanks
