Montezuma Heritage Park Rt 31 Parking Lot Dedication Saturday, September 17, 2022; 2 PM

An important improvement for both the Town of Montezuma and the New York State's 750 mile-long Canalway System has been completed. The project was awarded grant funding from New York State Office of Parks, Recreation and Historic Preservation (OPRHP) EPA Grant Program in 2018.

The project has been a successful collaboration between New York State, Town of Montezuma Highway Department, Friends of Montezuma Heritage Park volunteers and the Cayuga County Soil and Water Conservation District.

The parkland was first acquired from a grant received through the Outdoor Recreation Development Land and Water Conservation Act of 1965. The Town Supervisor who initiated the proposal was David Butler, Jr., serving the Town from 1954 to 1965. Following his term Byron Lapp, Sr. completed the land acquisition by transferring seven parcels that were designated for the development of a park.

Both men were dedicated to serving their country, family, and community providing leadership while leaving a legacy that lives on today. If they were still with us today, I'm sure they would be proud to see their vision a reality. With the completion of the parking lot, visitors traveling the New York State Canalway Trail and Empire State Trail will now have direct access to the park. Now visible from the state highway,, the entrance to the park from Route 31, it opens up this important local asset where it can provide residents and visitors active and passive recreation while enjoying the natural and historic beauty of the area. The interpretation of this site preserves the story of the Canal's evolution and contribution that also opened up transportation to the Nation.

The Route 31 Parking lot will be dedicated in David Butler, Jr.'s honor at the dedication on September 17th at 2 PM, and the public is invited to the event. In case of inclement weather, it will be held at the Town Hall. The Town will also recognize the important partnering organizations, volunteers, and in-kind donations who without their generosity and dedication would not have made the completion of the project possible.

Montezuma Heritage Park named one of four area State Birding Trails

A New York State Birding Trail was recently completed, and Montezuma Heritage Park, Montezuma Audubon

Center, Montezuma National Wildlife Refuge, and the Northern Montezuma Wetland Management Area are among local designations. Thanks to Alyssa Johnson at the Audubon Center for alerting me to the online application that I submitted and was approved last spring. Look for our new signs provided by DEC located at the trailheads.

The New York State Birding Trail showcases the diverse variety of habitats and landscapes and more than 450 species of birds found here. A new area was recently cleared by Tom Fitzsimmons southwest of the Route 31 parking lot. It opens a prime area in the park for birding.
