Supervisor David Corey opened the Public Hearing at 5:30pm, led by the Pledge of Allegiance.

Motion made by Thomas Hitchcock Jr. at 6pm second by Thomas Fitzsimmons to adjourn the Public Hearing and open First Budget Workshop. Motion carried 4/0.

Motion made by David Corey second by Thomas Fitzsimmons to pass the Local Law #1 for the Town of Montezuma Noise Ordinance, (No cost to the Town for the Law to enforce this ordinance). Motion carried 4/0.

David Corey went to a water meeting for the City of Auburn and their goal is to lower the water rates, County wide. Tried to do this 10 years ago with no success. The City of Auburn is going to bare the cost of this and put it into the water rates. We get our water from Cayuga County Water & Sewer Authority, so if they're signed on with this agreement then our Town is already involved. This Resolution is just a memorandum and not legally binding according to Town Lawyer Kevin Cox. What they want to do is come to every Town and see if they can improve the efficiency, with the goal of lowering the water rates. And right now the Town of Montezuma pays the highest rates of anyone in the system. The City of Auburn has hired a consultant (\$100,000 over 3 yrs) to see if he can equalize rates, like they did with the sewer rates, (now all unified). Marvin King asking why seniors they can't pay for just what they use and the service charge \$2.00 per gallon used, instead of the minimum, (10,000 gallons) \$121.50 per quarter. Per Thomas Fitzsimmons, you have to have this set up this way for our system to work. (We don't make any money on this, but should break even), last report Dec.2023 earned \$175,459 and paid out \$174,124. David Corey stated that if they are in need of help there is a program for this. David Corey can we sign this agreement, this way Seth Jenson (when he

goes to City Council) can say we are unified. Motion made by Thomas Hitchcock Jr. second by Thomas Fitzsimmons for David Corey to sign the memorandum of understanding. Motion carried 5/0.

Resolution For C2ae to act as representative of the Town of Montezuma to make all necessary applications to Rual Development (Federal Government). Applied into the State already, NYS revolving fund. We need the full report to review before we can agree with this. David Corey will call to get the full and corrected report, maps etc.

Tax Cap, raise 2% (\$10,000 Town wide).

All employees receiving a 3% raise for 2025.

A1410.1 – Town Clerk personal services, gave more than 3% raise as Marie Cronin is doing a great job. Raised from \$15,000.00 to \$16,000.00.

Thomas Fitzsimmons stated about the protective glass for the office that we haven't done yet.

A1440.4 – Engineer Contractual – C2ae Bill Kimball (see if he can meet with us) lan under bid job but the Town would not be responsible for this, (new water tank, 2 million) way too high. Everything is at a higher elevation and have 60 pounds of pressure so we shouldn't need a tank. lower from \$24,500.00 to \$12,000.00.
