2025 Tax Collection Schedule:

January 1st through March 31st, 2025
Monday thru Friday, 11 AM until 2 PM – **except** Wednesday, February 12th and March 12th.

Taxpayers are encouraged to pay by check, money order, or official check made payable and mail to:

Montezuma Tax Collector
P.O. Box 357, Montezuma NY 13117.

When paying in person with cash please bring the exact amount if possible. If you are unable to make your payment during the scheduled tax collection office hours, please call 315-776-8844, ext. 4774, during office hours, or 315-776-8583 to schedule an appointment.

Payments made by Bill Payment Checks from a processing center must be physically received on or before the due date shown on the tax bill for full payment, first installment, full payment with 1% penalty or full payment with 2% penalty based on the postmark rule application. Tax payments sent via privately metered mail are **NOT** postmarks and are considered paid upon receipt. **Payments not physically received by the due date will be returned.**

Dog Control & Sheltering
